Re: February 2019 Financial Statements

The February 2019 Revenue and Expenditure Reports and Balance Sheet are enclosed for your review. Financial reports are reviewed by the Executive Committee prior to inclusion in the meeting packet.

The Revenue and Expense report compares actual year to date receipts and expenses to the FY18-19 budget adopted by the Commission at the June 28, 2018 meeting. The financial operations of the agency are somewhat fluid and projects, added and modified throughout the year, along with the high volume of Workforce program activities, impact the adopted budget. To provide clarity, separate revenue and expense reports are now provided for Commission and Workforce Development Board activities.

As of month-end February 2019 (67% of the fiscal year), Commission overall year to date revenues are 53% and expenses are 58% of adopted budget. The two largest budget expense lines, Salary and Fringe, are in line with fiscal year at 66% and 69%, respectively. Revenue lags expense monthly (\$53K) and year to date (\$71K) due to expenses incurred on projects that are not yet invoiced. This amount is reflected in Net Projects on the balance sheet. Commission revenue flucuates as most projects are not invoiced on a monthly fixed amount basis.

We have previously reported on heavy expenses year to date in several line items. Printing expense is related to annual report production. Overages in Advertising and Professional Services are due to unbudgeted, but reimbursable, project expenses. Expenses for Communications, Office Supplies, Postage, Dues/Pubs and Miscellaneous Fees are anticipated and budgeted.

Looking at the balance sheet, Accounts Receivable total is \$576,317. Of this total, Workforce receivables are \$485,355 (84%) and current. The Executive Committee reviews all aged receivables over 60 days and no receivables are deemed uncollectible. Net Projects (\$168,171) represents current year project expenses, primarily quarterly and benchmark projects, that cannot be invoiced yet and posted to receivables.

This letter is in response to the scoping request for the above-referenced project.

As you may know, the Department of Environmental Quality, through its Office of Environmental Impact Review (DEQ-OEIR), is responsible for coordinating Virginia's review of federal environmental documents prepared pursuant to the National Environmental Policy Act (NEPA) and responding to appropriate federal officials on behalf of the Commonwealth.

DOCUMENT SUBMISSIONS

In order to ensure an effective coordinated review of the NEPA document, notification of the NEPA document and federal consistency documentation should be sent directly to OEIR. We request that you submit one electronic to eir@deq.virginia.gov (25 MB maximum) or make the documents available for download at a website, file transfer protocol (ftp) site or the VITA LFT file share system (Requires an "invitation" for access. An invitation request should be sent to eir@deq.virginia.gov.).

The NEPA document should include U.S. Geological Survey topographic. We strongly encourage you to issue shape files with the NEPA document. In addition, project details should be adequately described for the benefit of the reviewers.

ENVIRONMENTAL REVIEW UNDER THE NATIONAL ENVIRONMENTAL POLICY ACT: PROJECT SCOPING AND AGENCY INVOLVEMENT

As you may know, NEPA (PL 91-190, 1969) and its implementing regulations (Title 40, *Code of Federal Regulations*, Parts 1500-1508) requires a draft and final Environmental Impact Statement (EIS) for federal activities or undertakings that are federally licensed or federally funded which will or may give rise to significant impacts upon the human environment. An EIS carries more stringent public

participation requirements than an Environmental Assessment (EA) and provides more time and detail for comments and public decision-making. The possibility that an EIS may be required for the proposed project should not be overlooked in your planning for this project. Accordingly, we refer to "NEPA document" in the remainder of this letter.

While this Office does not participate in scoping efforts beyond the advice given herein, other agencies are free to provide scoping comments concerning the preparation of the NEPA document. PURPOSE OF NOTICE: To seek public comment on a draft permit from the Department of Environmental Quality that will allow continuation of an existing surface water diversion for hydroelectric power generation from the Little River in Montgomery and Pulaski counties, Virginia

PUBLIC COMMENT PERIOD: For 30 days, starting from the day after the notice is in the newspaper: **March 3, 2019** to **April 1, 2019** at 5:00 p.m.

PERMIT NAME: Virginia Water Protection Permit issued by DEQ, under the authority of the State Water Control Board

APPLICANT NAME, ADDRESS AND PERMIT NUMBER: The City of Radford, Virginia, 701 Seventeenth Street, Radford, Virginia 24141; VWPP No. <u>18-0555.</u>

PROJECT DESCRIPTION: The City of Radford, Virginia has applied for a Virginia Water Protection (VWP) Permit for the City of Radford Municipal Hydroelectric Project. The application requested authorization of an existing surface water diversion at the Little River Dam and Reservoir, located along the boundaries of Montgomery and Pulaski counties, Virginia. The City produces hydroelectric power from a diversion of water from the Little River Reservoir. No impacts to surface waters are proposed. The continued diversion affects the Little River in the New River watershed. A watershed is the land area drained by a river and its incoming streams. DEQ's preliminary decision to issue the permit.

HOW TO COMMENT AND/OR REQUEST A PUBLIC HEARING: DEQ accepts comments and requests for public hearing by e-mail, fax or postal mail. All comments and requests must be in writing and be received by DEQ during the comment period. Submittals must include the names, mailing addresses and telephone numbers of the commenter/requester and of all persons represented by the commenter/requester. A request for public hearing must also include: 1) The reason why a public hearing is requested. 2) A brief, informal statement regarding the nature and extent of the interest of the requester or of those represented by the requestor, including how and to what extent such interest would be directly and adversely affected by the permit. 3) Specific references, where possible, to terms and conditions of the permit with suggested revisions. A public hearing may be held, including another comment period, if public response is significant, based on individual requests for a public hearing, and there are substantial, disputed issues relevant to the permit.

Economic Development:

- The towns of Rich Creek and Pearisburg will hold their contract negotiation meetings with the Dept. of Housing and Community Development for their significant downtown block grant projects on 3/25.
- On 3/21 Montgomery County issued the RFP for a Broadband Infrastructure Assessment to include the county and the City of Radford. Proposals are due 4/25. A management team of stakeholders is being developed currently. The RFP can be found on the county website.

Transportation:

- NRV Rail 2020 will hold a meeting on 4/30 2:00-4:00 at the Christiansburg Aquatic Center. The focus of the meeting will be presentations from an architecture studio at Virginia Tech that spent the semester working on station designs under the leadership of professor Jack Davis. I worked with the class on two occassions assisting with the technical guidelines.
- The NRVMPO is seeking a resoultion of support from the Regional Commission at the March meeting to pursue a funding request to VDOT for planning funds to evaluate the Valley to Valley trail corridor.

Regional:

• The NRV Livability in Action Regional Exchange was held on March 7th at the German Club in Blacksburg. The event had the highest attendance to date with approximately 160+ participants. The day started with a fun trivia game based on NRV progress on livabilty goals utilizing cell phones to access an online platform. There were 12 lightning round presentations covering numerous topics such as the roamNRV bikeshare, early childhood education and the Calfee School project in Pulaski. We held a panel discussion with agency leaders from Richmond and concluded the day with a performance by the JAM muscians, an afterschool traditional music program for elementary school children.

Commission:

- The Commission recently hired Nicole Hersch for our vacant Regional Planner/Community Designer position. Nicole has a BA in Communications, AS in Landscape Design, MS in Natural Resources and MS in Landscape Architecture. She will start part-time in April and full-time in mid-May. She will support the Watershed Roundtable and many planning design projects.

- NADO held our annual policy conference in Washington, DC earlier this week. In conjunction with the conference, the VAPDC hosted a congressional briefing with Hill staff on 3/19. Nine Executive Directors delivered a presentation and held a roundtable conversation with the legislative directors for many of the Virginia congressional offices.
