V. REVIEW OF MUTUAL CONCERNS AND COMMISSIONERS' REPORTS

Mr. Fijalkowski reported a new ballpark, Creed Field, will open in Shawsville this month. Ms. Anderson reported Blacksburg will host a Blues, Brews and BBQ festival on September 28th and the second floor of the Black House Museum will open October 5th. Mr. Law reported Pembroke Heritage days will be September 28th. Mr. Patton reported the Floyd Craft Fair will be held on October 5th. Mr. Horton reported Radford will host Craft and Draft September 28th and the Highlander Festival will be October 12th. Mr. Collins reported Wing will host a drone delivery demonstration at the Christiansburg Moose Lodge on September 28th.

VI. CHAIR'S REPORT

Mr. Harvey reported he participated in a presentation Mr. Byrd delivered on Regional Commission activities at the Montgomery-Radford-Floyd NAACP branch meeting. He also attended the Blacksburg Partnership Transportation Committee meeting. The I-81 committee will hold a meeting October 1st at Natural Bridge State Park in Lexington. He recognized Janet McNew's retirement following 20 years of service and presented her with a gift from the Commission.

VII. EXECUTIVE DIRECTOR'S REPORT

Mr. Byrd provided a summary report in the Commission agenda packet. He reported the Commission anticipates positive news for Giles County on the US EPA technical assistance program, Recreation Economies for Rural Communities. The assistance will help advance work to connect communities to surrounding natural resources.

NRV Rail 2020 will host a legislative reception on October 3rd, 5:30-7:00pm, at the Great Road on Main in Christiansburg. The Secretary of Transportation, Shannon Valentine, will provide remarks. Commission staff will be following up with local governments about their support to establish an authority to own/operate the NRV Passenger Rail Station with the intent of securing General Assembly enabling legislation in 2020.

The Regional + Local Housing Study team will be meeting with elected officials in work sessions over the next couple of months to review community-specific data and local strategies for inclusion in the final report which is anticipated for release in January.

On September 30th Mr. Byrd presented to the Indiana Legislature on New River Valley collaborations for implementation. The session was designed by the Pew Charitable Trust to assist states with research on impactful regional initiatives.

Lydeana Martin, Floyd County Community and Economic Development Director, was selected to participate in the inaugural class of the Appalachian Regional Commission Leadership Institute.

Mr. Byrd thanked Ms. Schumaker and Radford University for providing tickets for the Commission to attend the Radford University Discovery Institute event. The Valley to Valley Trail received notice to proceed from VDOT and an on-call consultant was assigned to work on the planning phase. The annual Commission staff retreat will be held on Friday, September 26th, and will focus on updating the Commission's website.

IX. NEW BUSINESS

A. New River Health District Programs/Initiatives

Dr. Bissell provided updates on the programs and initiatives underway at the New River Health District. The health district leads and partners on numerous programs throughout the region, many of which run through local health departments hosted by each county and the city. Dr. Bissell discussed several of the key challenges our region faces pertaining to public health. The department focuses on education, prevention and treatment. Staff are observing an increase of Hepatitis A cases in the region and keeping a close watch on Hepatitis C. The number of sexually transmitted infections in the region has rapidly increased over the past four years. As a result, the health department has increased educational resources, outreach programs and treatment for people at risk. The Regional Commission has provided mapping services for the health district pertaining to Hepatitis C along with other public health program areas such as well and septic locations.

B. Comprehensive Economic Development Strategy – Consumer Version Mr. Byrd explained the 'consumer version' of the Comprehensive Economic Development Strategy (CEDS) provides a user-friendly overview of the CEDS content for public distribution, including information about the CEDS, the region's economic development goals, top-ranked projects, and select regional demographic and economic data. Staff will begin the next annual update later this fall, reconvening the CEDS think-tank committee to update the CEDS to reflect recent economic development trends.
